#### Chair's Report 2014 Spring Meeting – Dallas

Welcome to Dallas. The theme of this meeting is *Chemistry and Materials for Energy*. I would like to extend a warm welcome to any new Executive Committee (EC) members as well as any guests at our activities. Our monthly EC teleconferences have helped us to continue making progress on several projects. Our 2013 Annual Report was submitted on time; the narrative report was prepared by Ralph Stuart and the financial report was completed by Neal Langerman. Debbie Decker attended the 2014 Leadership Institute in January in Dallas, TX. We note with pride that Diane Schmidt, our 2013 Chair, was elected the 2014 President-Elect of the Society.

In follow up to the Chemical Safety Board (CSB) report on academic laboratory safety, CHAS members have been involved in an ACS Safety Initiative in partnership with the Committee on Chemical Safety (CCS) and Corporation Associates (CA). The following documents are part of this initiative: the CCS Safety Culture document published in 2012; the CCS Hazard Analysis document published in 2013; a CHAS/CA/CCS document on employer expectations of safety awareness among new hires (in preparation); a CCS Best Safety Practices document (in preparation); and a CA/CHAS document on fostering safety at academic-industrial partnerships (in preparation).

Safety Stratus has agreed to fund our College and University Health and Safety Award for the next five years. We are most grateful to Aditya Avadhanula and Safety Stratus for their support of this award. Thanks to all the CHAS members who identified potential sponsors. We thank NIOSH for their financial support of this award in the recent past.

Russ Phifer and other members of the Task Force on Laboratory Chemical and Waste Management prepared a comment letter that ACS submitted to the EPA regarding Land Disposal Restriction requirements. This is a great example of how we can interact with governmental agencies in a proactive manner.

CHAS has three technical sessions and is a cosponsor of a Presidential Event (Benefits of Chemistry in our Lives) at this meeting. All of the technical sessions have cosponsoring groups, so our networking with other divisions and committees continues to bear fruit. Plan to attend our joint social with SCHB and PROF on Monday evening. Our San Francisco program looks to be loaded with informative symposia. Our Program Committee is already organizing symposia for the Denver meeting in 2015.

I would like to thank everyone on the 2013 Executive Committee for their work during the past year. Thanks to Diane Schmidt for representing all of us so well as 2013 Chair. Ralph Stuart has continued to excel as our Secretary, which included the writing and submitting (no easy task) our annual reports. Neal Langerman has kept our financial affairs in order and has also prepared our annual financial report. Thanks to all for a very good year. Let's be careful out there!

On February 10 and 11, 2014, a group of 25 **chemical information** and **chemical health and safety** professionals met in Ithaca, NY to discuss development of an **open architecture for chemical risk assessment and management information** designed for use in academic laboratories. The purpose of the workshop is support *improved laboratory safety programs in academic teaching and research environments*.

The workshop, sponsored by the **American Chemical Society**'s <u>Committee</u> on Chemical Safety, Division of Chemical Health and Safety and Division of <u>Chemical Information</u>, reviewed a <u>strawman model</u> for such an architecture as well as<u>various web resources</u> available to implement such a model.

Presentations on these topics were given by representatives of Bristol Meyers Squibb, the University of Southampton in the United Kingdom, the University of California, SUNY Potsdam, the Royal Society of Chemistry, and Cornell University.
















#### Immediate Past Chair's Report – Diane G. Schmidt ACS Division of Chemical Health & Safety Spring 2014 Dallas National Meeting

#### 2013 in Review

Many thanks go to the Executive Committee [EC] members and others who worked to advance the Division's goals in 2013. The EC continued to meet monthly via teleconference in addition to the face-to face two national meetings.

Some of the 2013 accomplishments include:

- The Division moved forward with two innovative project grants with funding from DAC and one project with funding from Corporation Associates. They follow.
  - The Safety Lessons Learned Project was a joint project with the AIHA Lab Safety committee and CSHEMA. The project was completed July 2013. A peer reviewed form for describing lab incidents is now available on our web site. Work is in progress to incorporate this form into related division projects.
  - DCHAS partnered with CINF to develop a Risk Assessment Workshop. The workshop was held February 2014.
  - CHAS initiated the development of an Online Safety Certificate Course Project in 2013. The purpose is to develop and implement an online, certificate-level course on laboratory safety in the research laboratory for students at modest cost to students. The project is in progress. It was funded by Corporation Associates.
- DCHAS and CCS collaborated on a Hazard Assessment document. The draft document was posted for comment on the CCS website after the 2013 Indianapolis Fall ACS Meeting. The Task Force is completing comment resolution with a target to post the final document by the 2014 Dallas Spring ACS Meeting.
- The Division provided a robust schedule of Technical Programming and/or Workshops at all national and regional meetings.
- The CHAS regional meeting presence was expanded, especially via workshop offerings.
- The CHAS Administrative Manual was updated to address a variety of issues.
- Erik Talley and Neal Langerman were selected ACS Fellows in 2013.
- The Division presented three awards to key Chemical Health and Safety contributors in 2013. They are:
  - North Carolina State University: NIOSH/CHAS Collegiate Award
  - Neal Langerman: Tillmanns-Skolnick Award
  - P&G Children's Safe Drinking Water: Howard Fawcett Award
- A new sponsor for the Collegiate Award for 2014 was secured. The 2014 award will be called the Safety Stratus / CHAS Collegiate Award.

#### Division of Chemical Health & Safety COUNCILOR REPORT

#### American Chemical Society 246th ACS National Meeting Indianapolis, Indiana September 11, 2013

Division Councilors Bob Hill and Russ Phifer attended the Council meeting in Indianapolis. The following report summarizes actions that may be of interest to DCHAS members.

• The candidates for the fall 2013 ACS national election were announced as follows:

#### Candidates for President-Elect, 2014

Dr. G. Bryan Balazs, Associate Program Leader, Lawrence Livermore National Lab, Livermore, CA

Dr. Charles E. Kolb, Jr., President and CEO, Aerodyne Research Inc., Billerica, MA

Dr. Diane Grob Schmidt, Section Head R&D, The Procter & Gamble Company, Cincinnati, OH

#### (Subsequently, the ACS membership elected our Chair, Diane Schmidt as President-Elect – Congratulations, Diane!)

#### **Committee Reviews**

 As part of a regular committee performance review, the Council voted to continue the joint Board-Council Committee on International Activities and the Council Other Committee on Nomenclature, Terminology and Symbols. Continuation of the Committee on International Activities also requires Board of Directors concurrence.

#### **Realignment of Electoral Districts**

 ACS Bylaws require that the six electoral districts – from which six directors are elected to the ACS Board of Directors – be balanced in their total member populations. The Council voted to approve a proposal by the Committee on Nominations and Elections to realign these districts. The realignment meets the specified criteria for redistricting as required by Bylaw V, Section 4a and brings all six districts within permissible population range. This change takes place in 2014 and does not affect the 2013 national ACS elections. Councilors and others may visit the N&E website to look at the actual proposal and its impact.

#### **Meeting Registration Report**

• As of the morning of September 11, 2013, the ACS fall national meeting had attracted 10,840 registrants, including 6,630 regular attendees and 2,584 students.

#### Divisions

• After much debate, a proposed name change for the Division of Colloid and Surface Chemistry to the Division of Colloids, Surfaces, and Nanomaterials was defeated by the Council in a close vote.

#### **Special Discussion Item**

- A special discussion item was put on the Council agenda for this meeting. ACS President Marinda Wu presented and moderated a discussion on "What can we – as the Society and as individual citizens – do to help create jobs or demand for chemists?" Following the presentation, numerous Councilors engaged in a discussion of this focused topic on possibilities to encourage jobs creation and offered several suggestions.
- On the recommendation of the Committee on Budget and Finance (B&F), the Board voted to approve an advance member registration fee of \$380 for national meetings held in 2014.
- The Board confirmed the recommendation of the ACS Executive Director/CEO of the new President of Chemical Abstracts Service (CAS).
   He is Manuel (Manny) Guzman, most recently Executive Vice President of Learning and Research Solutions of Cengage Learning.

#### **Other Society Business**

 The Board voted to hold the December 2015 Board of Directors meeting in Honolulu, Hawaii, in conjunction with the 2015 International Chemical Congress of Pacific Basin Societies (Pacifichem). The ACS is the host society for the 2015 Pacifichem meeting, and co-location will allow Board members to participate in this very successful Pacifichem meeting.

#### Workshops Committee Report Dallas Meeting, Spring 2014

We are anticipating a minimum of 23 attendees for workshops at the Dallas meeting. This represents a nice increase from the past few meetings, and includes seven registrants for the new Hazards Analysis workshop. It is always a great sign to see such a significant advance registration for a first-time workshop. Registration is still open for these classes, but as of February 17, here are the advance registration numbers:


